The Vigil Honor is a high mark of distinction and recognition reserved for those Arrowmen who, by reason of exceptional service, personal effort, and unselfish interest, have made distinguished contributions beyond the immediate responsibilities of their position or office to one or more of the following: their lodge, the Order of the Arrow, Scouting, or their council scout camp. Under no circumstances should tenure in Scouting or the Order of the Arrow be considered as reason enough for a Vigil Honor recommendation.

The El-Ku-Ta Lodge Vigil nomination form is attached to this cover letter. You may download additional copies of the nomination form on the Lodge website at www.elkotalodge.com. Letters of recommendation are **required** as stated in Section IV of the nomination form, and should specifically address the information listed. Each nomination must have an **honorable** American Indian name and its English equivalent for the candidate. Use the American Indian/English translation from the Lenni Lenape Word List found in the back of the *Order of the Arrow Handbook* or from another credible American Indian language text. The American Indian name should be selected in a serious manner, based upon each person's qualities, talents, or traits.

- Service to other activities such as Church, School, Civic Organizations, etc.

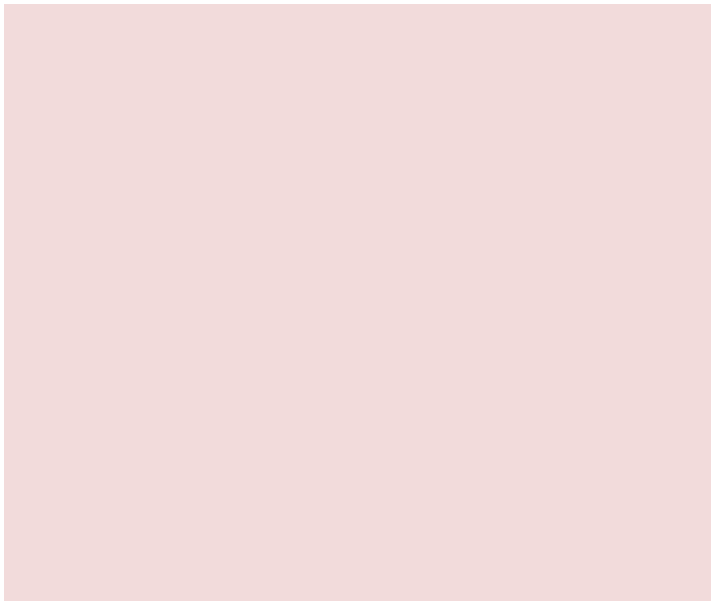
